

Preface / Dedication

Preface: The “*Greatest Experience*” in my life is having the “Opportunity” to raise a girl and a boy. I could be “a kid again!” I came to realize that one of my passions is taking pictures, would be realized – now I had “subjects.” But what an “awesome responsibility”, if taken “unselfishly serious.” Kids don’t ask to be born. There is “no blueprint” on how a child is to be raised, none was given for Kristen & Carlton. Kids, when born, are like a “*piece of clay*”, they have to be molded and nurtured into “**BEING**”. There are good books out there on child development (“First Three Years of Life” – Burton White), but none expressing the specific challenges facing a parent about his (or her) child. Probably not feasible.

What some refer to as “Old School” ways, well, some of those approaches are appropriate for even today.

1st, you must “Love the Child”, placing their “needs” above your own. It’s worth repeating, “Children aren’t ask to be born into this world”, you have a responsibility to put them in a better place than yourself.

“**Love & Limits**” and setting goals, for me, are essentials to child development.

For me, the three cornerstones you need to be on fertile ground to raise a family. 1.) a good Bible-Based Church, 2.) a Solid School System and 3.) a Solid Community. Having been brought up in a Baptist Church, I asked Mom, “What was the difference between African Methodist Episcopal (AME) and Baptist?” She responded, “AME’s put a heavy emphasis on “Education”, their ministers have college degrees from Seminaries.

As you will read later, Carlton & Kristen benefited “Spiritually, Educationally and Monetarily” by being brought up in 1st AME. A child’s 1st education from home takes place in church, if you take your kids to Sunday School.


Dedication: This book is dedicated to my two children, Carlton & Kristen, so they will know “*Thought*” was given to “how they were raised.”

Every Father should be required to go through "La Maze" – parental training to be allowed to participate in child birth.

Tracey was not having "strong contractions and had only "dilated" to 2cm, should be "8 to 12"cm (open), for the baby to be delivered. Her "water broke," causing a "c section" procedure. I was not allowed to attend (Dr. Boone not Dr Davidson) although I attended the required La Maze Classes. On April 28, 1987, a "6 lb. 6 1/2 ounce and 20 inch baby boy was delivered and named Carlton Hedrick Hoyles. He was then transferred to the Infant Section.

In recovery, the Nurse came in and told Tracey she was going to have to walk (several hours after the c-section procedure). She tried and started hurting, I told her "lay down you are not going anywhere today", while looking at the nurse, she walked out.

In looking back, on the Fetal Monitor, Carlton's heart rate was faster than Kristen's.





My best gift

My best gift was my little sister, Kristen Joi Hoyle. At first when I was the only child, I was lonely and had no one to play with except my cousin Quintin Hedrick, but I don't see him as often as I wished. So on 1990 May 4, Kristen was born and I didn't feel so lonely any more, and that's when I learned to appreciate my sister more.

Kristen's birth was predetermined (C-Section), would be a C-Section procedure and was scheduled for May 4, 1990. This time, Dr. Davidson said "We will have a good (positive) time!" Very upbeat, Dr. Boone was skeptical, even though I went through "La Maze" at the hospital she was to be delivered. Tracey was given an "epiderol" (shot in the spine), which meant she would be awake during the process..

1st House / 1st Home – Selecting our 1st house was a good experience, easier than buying a car. Having been educated by a former boss, Gary Johnson at CNA, about the benefits of going FHA, Tracey and I looked at a total of 13 houses in Merrillville, Indiana. Vickie Wilson was an Associate Broker (Price Realtors). When I saw the house at 1620 Dale Drive (Meadowdale Area), I felt good about the house and location. Mrs. Wilson indicated early that we would get a feel for the prices of homes based on common amenities (some with or without basements, 2 versus 1 car garages, etc.) I had an idea about the price. "If \$62,000 is the price, I would offer \$60,000." It was \$62,000 and the seller accepted my offer of \$60,000. The offer was accepted but it was "contingent" on an "independent appraisal." Surprisingly, the appraiser was Charles Hughes Realty – Chucky Hughes's Dad and he appraised the house for \$57,500. The sellers, a minister and his wife, accepted the offer of \$57,500 and they moved to the Winton Woods Area in Ohio, about 4 miles from where I grew up. The \$2,500 difference would save us over \$21,000. We initially put up earnest money of \$800 (February, 1986) and at closing, we paid an additional \$2,680 (May, 1986), \$3,480 in total.

Now, we had a house, it was only when Carlton & Kristen were born did we have a "Home". Carlton was born on April 28, 1987, one year after we purchased the house.



"Becoming a Block Captain (Community Involvement)" - In the early 1990's, having secured a home (1986), starting to raise 2 kids (Carlton, 1987 & Kristen, 1990), here comes the "Latin Kings".

While cutting my grass, a car of "want to be" Latin Kings (gang bangers), drove in front of my house and threw out some trash. I yelled for them to "Stop" the car and they did. As I approached the car, I asked "who threw out the trash?" No one responded, so, I pulled one of them out from the back seat and had him pick up the trash. I told them "if you harm any member of my family, I am not going to call the Police, I know where you live and I am going to come after you." I repeated the same statement at a "scheduled" meeting with our Police Dept. and the neighbors. One neighbor (a Fireman) also repeated my statement to the "want to be Latin Kings" when he encountered them about his son.

These problems all started when this Hispanic Family (husband, wife and 2 boys) lost (or was killed) the Father, with the wife left to raise the two boys. The two boys were "mannerly," when they were young. As they got older, the eldest began associating with the "Latin Kings (Gang) of East Chicago". Easy to recruit the oldest when the local newspaper would print "The Latin Kings Rule (or own) East Chicago".

After that meeting with the Police Department, I knew I had to "step up my efforts" as a Block Captain. Prior to that, I just attended the Neighborhood Watch Meetings. So, I initially started to circulate a summary of the meetings to the 33 residents in my block but I expanded that to 155 residents. To help protect my family, I knew I needed to establish a relationship with Law Enforcement. Below are examples of the circulations.



Except for the residents on Dale Drive, Arthur Street and 54th Ave., North of Arthur Street, if you are a resident reading this and don't live on the streets mentioned, you need to become a Block Captain. It is a voluntary position (not elected) and everyone on these streets can become a Block Captain. You need to call the following numbers if the situation exist:

- Pit Bull Dog on Dale Drive**
 - I continue to receive concerns about the pit bull dog from neighbors (Grandmother afraid to let her grand kids play out in the backyard, newspaper boy chased awhile back; neighbor, with young kids, said his "kids like dogs and will run up to any dog, not realizing the danger – is there an ordinance addressing maintaining these dogs", etc.). There is a "Vicious Dog Ordinance", call Code Enforcement (769-3631) for further clarification on how these dogs should be secured.

In summary, keep in mind that "even with the above-mentioned items", the focus should always be viewed with "SAFETY FIRST" in mind, for adults and our kids.

“Early Years” – “The Rocking Chair”

“Life Saver after “Night Time Diaper Change & Feeding”



“The Rocking Chair” - a comfort to me and the kids, always at night. When Carlton & Kristen were babies, I would change their diapers and take them with me to warm up their bottle of milk (or formula – Infamil). This way, they could be with me, instead of leaving them in their beds.

I would do this because Tracey needed to sleep and I could change diapers “Better” – and would clean and use “Vaseline”, to cut down on diaper rash. Vaseline protected them from diaper rash “better” than the powders, etc. sold over the counter.

Feeding them while sitting in the “Rocking Chair”, Carlton would always be “half a sleep”. Kristen would always be “wide eyed”, watching me as I would be feeding her. I think this is why, when she got older (2 or 3 years old), she would call me to come sleep with her (“Daddy, would you come sleep with me”.) As she got older (3 or 4), Kristen would come and get in our bed and sleep between Tracey & me. I told both Carlton & Kristen that “if you guys need to sleep with us, don’t wake me up by calling out, just come and get between the two of us.”

Dental/Medical Health



Enough can't be said about "taking care of your teeth and practicing good dental hygiene!"

Growing up in the 1950's & 60's, anyone who experienced Dr. Clark (Dentist in the Valley – Hartwell, Ohio) realized "he was not practicing dentistry in your best interest."

As a result of me having to take a physical exam in order to compete in sports, Dr. Todd (Glendale) told me my teeth were HORRIBLE! He sent me up the street (Sharonville Rd.) to Dr. Halbauer (Dentist). I had a gold cap over my upper right cisor, which made me look old, I wanted it removed. To this day, I remember Dr. Halbauer saying "I need to save your mouth right now, I can remove the gold cap later!"

I quit seeing Dr. Clark and asked Mom "Why did you have us see Dr. Clark?" She responded "He was cheap" and I responded "But he was not good." As a professional, you can charge "cheap" but you need to do a "professional job, do excellent work."

I was in the 7th grade.

As I got older and had a family, I would only select Dentists and Doctors that were at least "40 years old, thinking that at that age, they should be experienced but still young."

"Braces" – Carlton (Dr. Bibbs – Chicago) and Kristen (Dr. Lesiac – Munster). Can't forget when they got "Braces"! The trips to Chicago, Illinois and Munster, Indiana.



Changing Diapers, Feedings & No Sleep - Prior to bringing Carlton home, we decorated and bought furniture for his room. "What a joyous occasion, the excitement, the expectation!" Since Tracey and I worked in Chicago (1st Chicago Bank & CNA Insurance Cos., respectively), we needed a babysitter. June Morgan, Tracey's Aunt and who was retired, filled that role.

Carlton was named Carlton Hedrick Hoyles, middle name being my wife's maiden name. This was how Mom named my brother Billy, using her maiden name, Harvey, as his middle name. Carlton was a "**Happy Baby**", always smiling. I would bring Carlton to Tracey when she was nursing and I never had a problem "changing diapers", felt I could do it better (used Vaseline to prevent diaper rash, after I would clean them up). "Old School", we used Vaseline as people use lotion today, puts on a "protective coat" on the skin. When they are your own, changing diapers was never a problem.

Enfamil, Enfamil ! Running to "Toys R Us" to get cases of Enfamil and preparing it at night to feed him. After burping him, I would just put him in the bed with us. As he got older, 1 ½ or 2, he would do "360's" in the bed and "scoot" to the edge of the bed, where I would catch him. Kristen never did that. "No Rest, No Sleep, No Rest for the Weary".

But, I remember when I was small, I would wait until Mom & Dad were sleep and I would crawl in between them, just as Kristen would when she was 2 or 3 and Carlton, occasionally.

Kids Sleeping with Parents – On a regular basis, absolutely not! But there are times, for whatever reason, kids will come to your bed in "the middle of the night." I told Carlton and Kristen "if you need to come into our bed, don't wake me up by asking, just come on in and get between us." A deceased friend of mine, Matt Bachmann, would talk about "clearing the way to our bed, at night, so when the kids came running, there would not be a **DISASTER** of running into the furniture." Parents fear that the child will continue that pattern of sleeping with them, making it more difficult to break them of that habit. They will find their independence, as time goes on. This is true in our case, Kristen lives in Indianapolis, Ind., Carlton lives in Lithonia, Georgia and "**I LIVE IN MERRILLVILLE, INDIANA (NOT GLENDALE)**".

LOVE & LIMITS

1. Promote a positive, loving relationship with your child.
2. Provide structure and reassurance through daily routine.
3. Set clear limits and enforce rules consistently.
4. Be realistic and fair in your expectations.
5. Use communication techniques that foster self-esteem.
6. Model good behavior.
7. Provide ample opportunity for your child to make choices.
8. Immediately disengage from power struggles.
9. Use positive reinforcement to encourage desired behavior.

“These are the ages I miss. I could tease, be silly and play games with them. On vacations, when I would say “To the pool”, they would respond. As they got older, not so.”




“Toll Truck Prank” (Kristen - 4) – One time I had to get the car (Volvo) tolled from the house to the Dealer. While waiting for the toll truck to come, I told Kristen, only one with me at home, that she was going to have to “drive the Volvo” while I sat up front with the toll truck driver. “Dad, I’m too little to drive!” “No you are not”, I replied. “I will put a pillow on the seat behind the steering wheel so you can drive.” She thought I was serious and to watch her agony was entertaining to say the least. When the toll truck driver came, I told Kristen I was “teasing”. She just frowned.


“Mommie Kisses” (Kristen – 3) – One night, about 8 pm, while I was washing dishes and Tracey was sleeping upstairs, Kristen came up from the basement into the kitchen. I picked her up in a way that I had her arms braced against me, so she could not get away. I kissed her and then the “teasing” began. I made kissing sounds and “hollered” upstairs to Tracey, who was sleeping, “Mommie, Mommie, Kristen is giving me all your kisses.” I kept repeating this routine – kissing sounds and calling to a “sleep” Tracey. Kristen got so furious because she always told Carlton that “Mommie is mine and Daddy is yours”. I got her so “rowded up” that when I let her go, she went “tearing up the stairs to Tracey. She jumped on the bed, grabbed Tracey, who didn’t know what was going on, started kissing her saying, “No Mommie, I didn’t give Daddy your kisses!” She just kept repeating this routine (kissing her and repeating this narrative). Finally we calmed her down and convinced her “Daddy was teasing!” Kristen’s response “Bad Daddy.”

“Hammies” (Carlton – 4 or 5) – I would play “boxing” with Carlton, but he wouldn’t want to “box me”, he would start sucking his thumb and would hug my leg. So, when I would hold him, I would “squeeze his quad in a ticklish manner.” He would frantically laugh and try to get away. So, in the future, when I would hold him and say “Oh Ginn”, he would respond “What” because he knew what was coming. “Let me squeeze those Hammies” and off to the races we would go! “Those little hammies!”

“The Boogie Man” (Carlton – 5) – One evening at home, Carlton was coming up from the basement, through the kitchen, to go upstairs to the bedroom. It was dark in the living room where I was. As he was about to go upstairs, I “Growled & Growled” and started towards him. He couldn’t really see me and became alarmed. So, he went flying up the stairs, towards our bedroom, screaming “Mommie, Mommie”, jumped into the bed and began hugging his Mommie in a panic. I kept “Growling” as I approached the bedroom door. Upon entering, Tracey said “Just Daddy!” Yes, just Daddy.

“These are the days I miss, because at 73, I still have a lot of kid in me still!!!!!!”





Reality is parents “need” to address a child’s needs, not their wants! No way or should you try to “equally” give the same to both!


Progress Report Folder

Maintained “Progress Report Folders” on Carlton & Kristen from Elementary School through High School.





Multiple Intelligences Overview

Definition: In Multiple Intelligence Theory, an intelligence is defined as the "ability to solve problems or fashion products that are of consequence in a particular setting" (Gardner & Walters, 1985).

Origins: Theory of Multiple Intelligences

- Implications of brain-damage on cognition;
- Incidence of isolated cognitive capacities among prodigies, idiot savants, and the autistic;
- Learning practices within differing cultures;
- Cognition patterns among diverse species; and
- Studies on training and the generalizability of skill acquisition.

Key Elements: Theory of Multiple Intelligences

important →

1. The intelligences are independent entities.
2. The intelligences interact to support and strengthen one another.
3. Individuals have MI profiles of relative strengths and weaknesses.
4. A strength in one domain can aid learning in another domain.

Implications: Theory of Multiple Intelligences

1. The primary task for schools is to provide maximum opportunities for individuals to develop their own potentials.
2. Assessment should permit a constantly evolving portrait of an individual's profile of intelligences, styles, interests, and motivations.
3. Projects can blend evaluation into curriculum and provide a more real life view of the student's capabilities.

A questionnaire accompanied this pamphlet. When these questions are answered, it helped map which "intelligences" apply to a person. I used this to identify my own "intelligences" and my kids. **But "Emotional Intelligence" is twice as important.**

"In the Beginning – The Early Years" – Elementary (Carlton)

With the 1st Progress Report Meeting with Carlton's 2nd Grade Teacher, Mrs. Stazinski and Mrs. Lynn (Reading Teacher), Mrs. Stazinski spearheaded the meeting. She stated "What are you doing" (addressing my wife & I) as if we were the problem. Even inferred that "other kids have traveled abroad", meaning Carlton didn't have a lot of exposure. Little did she know (or failed to acknowledge), most of the area residents were "IMMIGRANTS" from other countries and their parents traveled back to their homeland (example, my friend Damir Kovacic from Croatia). A very "undermining" meeting, we thought Mrs. Stazinski was going to be a "nice" teacher before the meeting. I told a coworker (Kara Johnson, MBA and from Mississippi) and her response was "***They start on our kids early.***" Mrs. Lynn talked to my wife & I on a more humane basis.

During Carlton's 2nd Grade Year, Mrs. Stazinski would do things to undermine Carlton's progress. As a result of one such incident, I called a meeting with the teachers (Stazinski & Lynn) and the Principal Dr. Salvo Marks. I asked "Why didn't Mrs. Stazinski follow her practice of "writing the homework assignment on Monday in his assignment book, which Carlton would then write subsequent assignments for the remainder of the week?" "All she did was wait until Thursday, drew a line from Tuesday through Thursday stating "where is his homework?" The Principal asked her why didn't she follow her "practice of assigning the homework". Mrs. Stazinski admitted she didn't follow her procedure and she was visibly upset. Before leaving the meeting, I indicated that we are never informed about the "next steps" to help Carlton improve, so I indicated that we were going to enroll him into the Sylvan Learning Center. When we came home after the meeting that day, his homework assignment was not in his assignment book. The next day, Tracey went into the school to confront Mrs. Stazinski about this, to my objection. I knew how Mrs. Stazinski would respond and at this point, I took Carlton's assignment book and went to Dr. Marks, Principal. He said "Don't worry about this" and eventually asked me to get involved and be on committees at the elementary and high school level, which I did.

Sylvan Learning Center wanted Carlton to start during the last month (May) of the school year, which I questioned "***Why do I want to have him, who is struggling in school, to start at Sylvan and have homework from both?***" Sylvan said "they wanted to talk to his teachers before they left for the summer", they lied, they never did. Sylvan charged us \$150.00 for testing him after I informed them they could get his test results from me or the school. During Carlton's experience at Sylvan, he sat at a table with "4 students of different grades" with one young teacher. It costs us \$17.00 an hour for tutoring, two days a week. The instructors were young teachers seeking evening summer jobs and this "setup" was a joke! Having watched Carlton struggle through 2nd Grade, reminded me of my 5th Grade experience. It would have been a "***Disservice***" to Carlton to pass him to the 3rd Grade so I consulted my sister-in-law, who had been a teacher for years, about retaining him. ***If you retain Carlton, it should be around or before the 3rd Grade.*** Carlton was retained in the 2nd Grade.

I asked Mrs. Preston, at 1st AME Church, to recommend a teacher to tutor Carlton. Mrs. Preston told me to contact "***Venetia Popular Brown***", a retired teacher, who still had a passion for teaching kids. After retirement, Mrs. Brown started a business of tutoring kids.

When I met with Mrs. Brown, she only wanted \$10.00 an hour and would tutor Carlton 2 hours on Saturdays. I told Mrs. Brown I would pay her \$35.00 because I paid Sylvan \$17.00 an hour for 2 hours a week (\$34.00). I wanted to pay her more than I paid Sylvan. From the summer, at the end of his 2nd Grade Year (when retained), Carlton started seeing Mrs. Brown on Saturdays from 8:30 am to 10:30 am. He saw Mrs. Brown from his 2nd (year retained) through the 8th Grade. He never complained during the 6 year period that he saw Mrs. Brown.

I wanted Mrs. Brown to concentrate on his "required reading" during the Summer and during the school year to focus on homework that he completed during the week. Mrs. Brodie, Carlton's 2nd grade Teacher (repeating) noticed his improvement during the year.




“Game Changer - Nikki Kutansky – Art”

Going to Carlton’s Freshman Year Progress Report Meeting with his Teachers, I took some of Carlton’s drawings. Most parents don’t spend time to discuss their child’s progress with the Art Teacher, their focus is on the “3R’s – Reading, (w)Riting & (a)Rithmetic.”

When meeting with the Art Teacher (Pratt), he was “insensed” that I brought Carlton’s Art work. “He copies”, he said, “that’s not Art”. I was visibly upset with his reaction and reacted. He later said Carlton should take classes on Life & Still Life Drawings. Familiar with Life Drawings from UC Art History Classes, I responded “A 15 year old drawing nude models, RIGHT!” He said he could attend with parental approval. He recommended or mentioned the “Performing Art Center” in Munster.

Although the meeting with this teacher was “contentious” and I was visibly angered by his comments, it was the best advice because Carlton met Nikki Kutansky – the Art Instructor.

While on the train going to work, a woman, that I sat next to, had her art work with her, she attended the Chicago Art Academy. I asked her about “copying” previously drawn “Art Work.” She responded that “In class, we are instructed to copy from famous artists’ drawings to get an understanding of the techniques used.” When I told her of Carlton’s Art Teacher’s response, her response was “High School Art Teachers can be FIRE EXTINGUISHERS, because of their own short comings.”

Learning the technical aspects of drawing at the Performing Art Center, under Nikki Kutansky, Carlton took the following Art Classes:

1. Beginning/ Intermediate/Advance Drawings
2. Still Life & Life Drawings (Principles of Figure Drawing)
3. Introduction to Cartooning
4. Advance Cartooning & Superheroes

Duration of the classes: 2 hours, one day a week, for 12 weeks.

Instead of “running track” during the summers, Carlton attended the Art Classes in Munster.

Carlton attended Indiana State University, where he enrolled in the School of Fine Arts. There he received a Bachelor’s Degree in 2-D Design. He wrote, illustrated and published his comic book ***“RENEGADES”*** (*PlanetNet.com*). Shortly after graduating from college, he interviewed and landed a position with ***“Marvel Live”***, a super hero show (Disney/Feld) playing various super heroes. He toured around the US and Europe (24 cities in the states and 17 cities in Europe). Being employed by Disney, he would also do ***“Disney Appearances”*** at various venues (White Sox’s Park, various comic outlets) and was the ***“Grand Marshall”*** at the 2019 Kentucky Derby as ***“Black Panther”***. He has appeared as a ***“Stunt Double”*** in various movies (Luke Cage, Black Adam and the remake of ***“The Color Purple”***, etc.)

Intermediate / Middle School “Controversy” (Kristen)

Since her 6th grade, I had been talking to the counselor about putting Kristen in a more “Challenging Program”. “Kristen is making all “A’s” and a B in her classes and is finished with her homework “EARLY” is what I told him. He told me he would correct that –“Some teachers are recommending students that don’t qualify and other teachers aren’t recommending one’s that should be.” Nothing happened.

Once Kristen was in the 7th grade, her teachers felt she should be in the “Honor’s Program”. Under a new Principal (James Joiner), I approached him about Kristen. He sent me Patti Eich’s comments on “not recommending Kristen for the “Honor’s Program”. I responded “vehemently” to her comments. While Ms. Eich was a 6th grade teacher , under Principal Tom Herbert, who I knew and worked with, Tom had Ms. Eich call me at work (CNA Insurance Co. – Chicago). The conversation ended with her stating *“she (Kristen) is a lovely girl but is DEFINITELY AVERAGE!”* Ms. Eich was upset that I got “Both Principles Involved!” I did this for ACCOUNTABILITY (see attached).

Kristen’s 7th grade Principal (James Joiner) decided to “move Kristen into the “Honor’s Program midyear. I told him “maybe we should wait until she goes to the 8th grade BUT he said “if we move her now while she is in the 7th grade, when 8th grade scheduling occurs, she will be scheduled automatically in the “Honor’s Program”.

After being transferred into the “Honor’s Program” in the beginning of the 2nd grading period of her 7th grade year, Kristen made “All A’s.” I emailed, with attachment, both Principals and Ms’ Eich, Kristen’s grades. I stated to Ms. Eich “Definitely AVERAGE, I Don’t Think So!” Kristen’s 3rd grading period (last of her 7th grade year), she made “All A’s Again!” I sent another email to the Principals and Ms. Eich, “Definitely AVERAGE, I Don’t Think So!”

In Kristen’s Senior Year, she graduated with a GPA of 3.4 in the Academic Honor’s Program” and received the “Indiana Honor’s Medal”, along with \$500.00. She was accepted in to Indiana University and received the “Hudson & Holland Scholarship” (\$20,000.00 over a 4 year period. (see attached picture.)

So much for Ms. Eich’s misguided assessment back then. When colleges evaluate your high school academic transcript, “Strength of Schedule” is critical. I am glad I fought to get her into the “Honor’s Program” in her 7th grade year.

Looking back when I was in high school, I questioned the counselor “Why was Class Rank not weighted since students taking College Prep., General, Fundamentals were lumped together?” She said don’t be concerned about that because statistics show “You have a stronger chance of making it in college by being in “College Prep. Program.” I was in College Prep.

“Concert Master”
Since 7th thru 12th Grade

Quintin, 3 years older than Kristen, was playing in the Northwest Indiana Youth Orchestra in Munster. Kristen wanted to join but you had to “try-out”. Kristen auditioned and landed a spot in the Youth Orchestra. Her practices were on Sundays from 6:00 pm – 8:00 pm.

Seeing Kristen’s desire to major in Music in college (Mrs. Kowalski, Oberlin College), I told her private lesson instructor, Kassie Meeks, to focus on meeting the requirements to allow Kristen to get accepted into a Music College.

Merrillville High School’s Orchestra Policy was changed when Kristen was a Freshman. Instead of letting the “Senior Violin Players Only” audition for 1st Chair, Mrs. Kowalski, Orchestra Instructor, discussed with Mr. Bradford, to let “all” audition for 1st Chair and “let’s take the best player.” Kristen became the “1st Chair – Concert Master.”

The Concert Master ‘tunes up” the entire Orchestra before a concert.

At the Orchestra Awards Banquet, Kristen received the “Florence Long Orchestra Award for Outstanding Freshman.” Kristen got a chance to play with Florence Long (in the picture to the left) in the “Combined Northwest Indiana Youth & Adult Orchestra Concert” at the “Holiday Star Theatre” (Raddison). Florence Long is Coach Atria’s Mother-in-Law and at the time, played in three different (Adult) Orchestras in Northwest Indiana.

To be in the MHS Orchestra, you are required to take “private lessons.” Kassie Meeks was Kristen’s “private lessons instructor.” Now, I had to drive to Valparaiso High School (25 miles one way), during the week, for \$400.00 over several weeks, for lessons. Instead of dropping her off and returning, I stayed and exercised. I would walk 4 times around the high school (6/10ths of a mile) and it would take about 50 minutes, her lessons lasted 1 ½ hours. Sometimes I would bring my dumb bells to weight train.


ISSMA Contests would have Tracey and I going to North Central High School in Indianapolis (during the Winter). Her solos were rated with “high marks.” I filmed all of her concerts (& solos).

I asked Amy Beckham (Assistant Athletic Director) if she would allow Kristen to play at a “Large Athletic Event.” She delivered by letting Kristen play the National Anthem at the “Semi-State Wrestling Meet.” After she performed, a coach from South Bend came out to the parking lot to congratulate her on her performance. MHS Principal, Mike Krutz, asked me if Kristen could play the National Anthem at her Graduation (2008).

After graduation, Kristen got accepted into the Jacob School of Music at Indiana University (see acceptance letter).

Ineligible player gives Merrillville title

✉ A Michigan City player was out sick and didn't have enough practices.

Michigan City's girls tennis players screamed and hugged after winning the Portage Regional title 3-2 over Merrillville on Wednesday.

The joy turned to sorrow when told they must forfeit due to an ineligible player.

The Pirates (13-3) replace the Wolves (17-2) at Saturday's LaPorte Semistate.

"(Team meeting) was real

difficult," coach Norm Bruehner said. "Our girls were devastated. They were shocked at first, then came anger and frustration."

And lots and lots of tears.

"They've been through lots of battles all year. Illnesses and injuries couldn't beat them, it took an outside ruling that beat them."

The veteran coach said he talked by telephone with the IHSAAs tennis director in Indianapolis and then Commissioner Robert Gardner made the final decision.

The issue was whether City's Jayne McCormick had the required four practices before

playing first doubles at the regional. She'd missed several days of school in early May with mononucleosis but received a doctor's release to return Monday.

McCormick and Stephanie Brown lost to Valparaiso on Tuesday. City won 4-1. They beat Merrillville's No. 1 duo easily in the championship.

She did not play in the sectional, Pirates coach Dave Zimmerman said. The 23-year veteran is aware of the rule but had never seen it come into play.

The bylaws say that a player who misses 4-9 days of school needs four practices before returning after being released.

Bruehner wasn't aware of the

role, noting the coaches' handbook doesn't use the same wording.

"It's open to interpretation," he said.

She played part of the season and had her (preseason) required practices in. We argued that we were unaware and acted in good faith.

Bruehner said the Portage tournament director (retired Indians coach Rich Mason) and other coaches also were unaware.

"Norm was totally honest," Mason said. "I have to commend him."

Said Bruehner: "It was never discussed at the coaches' mandatory rules interpretation

meeting in March. I wish someone had told us before Wednesday. We know now, it's very sad. We thought everything was fine which makes it that much tougher.

"It's a hard lesson, one we'll have to accept."

Bruehner said if the rule applied to all sports "there's probably many violations of it. I can't imagine football. I don't think many coaches know about it."

Zimmerman had no comment on how the ineligible player was found.

"I don't like the rule," he said. "It's there to practice players. It has a purpose, but rarely do you see something like this, a match

overturned.

"I have bittersweet feelings. They beat us 3-2 fair and square. I feel bad for Norm and his team."







Zimmerman learned of the IHSAAs ruling a phone message at 2:30 and scrambled to set up practice.





Portage coach Jessie Fox was proud of the Indians' performance and said it will be hard to say goodbye to seniors Holley Percfield,


Alyssa Mayerik and Kari Nugent. "My girls fought," Fox said. "They came out here and they played their hearts out."



From Guy Kawasaki, one the founders of Apple Computer, who helped create the MAC.

I received this article from an employee at CNA Ins.Chicago.

Reflecting on my "College Experience", over 6 years, resulting in two degrees (AA '70 & BBA '73), naturally I felt this was an excellent article. I didn't want to show my kids this until "after they graduated from COLLEGE (ISU & IU). This will become apparent as you read item #10.

Hindsights & Insights from Guy Kawasaki summarized:

1.) *"Enjoy your Family and Friends before they are gone."*

- Most important hindsight, Nothing, not money, power, or fame can replace your Family or Friends or bring them back.

2.) *"Obey your Absolutes."*

- There are rights and wrongs. Preserve and obey absolutes – "Be true to yourself."

3.) *"Play to win and win to play"*

- Winning is also a "means to play again". An "unexamined life" may not be worth living but the "unlived life" is not worth examining." Don't squander the rewards (money, power, self-confidence) of winning.

4.) *"Don't get married too soon."*

- 32 is a good age to get married. If you decide to get married, keep in mind that "you need to accept the person for what he or she is", RIGHT NOW!

5.) *"Learn to like yourself or change yourself until you can like yourself."*

6.) *"Continue to LEARN."*

- You should never stop learning. It's easy to study once you are out of school because you can see the relevance of why you need to learn.

7.) *"Learn to speak a Foreign Language, Play a Musical Instrument and play a non-contact Sport."*

- Studied Latin in high school to help me "increase my vocabulary – we took a lot of Latin vocabulary tests. Play a non-contact sport like Tennis or Swimming. You can play these sports once you are "over the hill."

8.) *"Challenge the Known and Embrace the Unknown"*

- One of the biggest mistakes you can make in life is to accept the known and to resist the unknown. Example – the story of Icemakers & Ice Harvesters of the 1800's. They never "embraced" technology (the refrigerator) and went out of business.

9.) *"Pursue JOY, not HAPPINESS"*

- Happiness is temporary (nice car, nice material things, etc.) and fleeting. Joy, by contrast, is unpredictable. Joy comes from "pursuing your Interest and Passions." **"STUDY WHAT YOU LOVE!"** Don't be Brain Dead! There are so many ways to make a living in the world. Don't force your child to follow in your footsteps or to live YOUR dreams.

10.) *"Live off your parents as long as possible."*

- Not popular with parents, who are paying the bills. Guy Kawasaki graduated in 3 ½ years but never traveled, which he says was a big mistake. "You have the rest of your life to work, so don't be in a rush to start (working for bozos that know less but make more money.) Your goal should be to "extend college for "6 YEARS"! I did but not on my parent's dime.







Also, he was not in the ISU Track Program Book, which when I confronted McNichols about that, he said it was a mistake because he submitted Carlton’s info.

“College Experience” – Carlton

I told Carlton to email Coach McNichols that he “**would not**” be running track and that “there are members on the team that didn’t score as many points as he did and they got more money.” Coach sent back a sarcastic response and we just moved forward.

Going into Carlton’s 5th year at ISU, I asked him “how many hours do you need to graduate?” He told me 17 hours. Turns out, his counselor told him he had 25 hours to complete and he could take 12 hours per quarter and she would waive the remainder. So I told Carlton to take 15 hours and I would pick him up after the Fall Semester and he could come home and work to earn enough to pay for his last quarter.

Carlton went to the Financial Aid Office to apply for a Government Loan and applied to be a Resident Advisor, something I would tell him since he was not going to be running track.

He got the Government Loan for \$6,000.00 and became a **Resident Advisor**, which would pay for room & board. He only needed \$4,000.00 for tuition, so I returned \$2,000.00 to the Government.

He graduated in May, 2011 from Indiana State University with a Bachelor’s Degree in 2-D Design.

Carlton received his Varsity Jacket prior to his email to Coach McNichols, who later died, years after Carlton graduated (2011), at age 65

Carlton’s situation was too much like my teammate, Scott Stargel, who named his youngest son after me. I told McNichols “you didn’t even offer him “Books”, even though he was recruited on an “Official Visit to ISU. So I didn’t want him to run track at ISU and instructed him to send Coach the email quitting.

Carlton never liked running track or sports like me, he wanted to focus on his Art and I wanted him to do just that!



“College Experience” – Kristen

College was a “roller coaster of emotions” for Kristen and me. Leaving home for the 1st time over an extended period of time, etc. While Carlton went through Indiana State University in 5 years, Kristen was my “prodigal child.”

Having entered Indiana University in the Fall of 2008 and receiving the “Hudson & Holland Scholarship (\$20,000 over a 4 year period), 1st year was challenging to say the least. Because her GPA at the end of the 1st and 2nd Semester didn’t meet IU’s standards, she had to come home and attend IU’s Branch (Indiana Indiana Northwest)

Kristen’s counselor at IU Bloomington indicated that she needed to make “*3 Semesters of A’s to get her GPA up to be back on scholarship.*”. Tall order to fill but he felt she could do it. She made all “A’s” the next two semesters, I would take her to the IU Branch during that time. For the third semester (which would be the Fall Semester), I asked Kristen if she went back to Bloomington, would she be able to make the final semester of A’s. I wanted her to be back on campus and she felt she could. So back to Bloomington she went. She was able to achieve this and put her GPA back over 3.0.

Having completed 3 years at IU, Kristen’s GPA was 3.2. She transferred and was accepted into the “Jacob School of Music”, which, at the time, was rated higher than the Juliette School of Music in New York, considered to be the top Music School in the US.

Still making life adjustments and having missed a semester at IU Bloomington, her scholarship money didn’t carry over. She enrolled at IVY Tech College. She eventually came back home and I decided to call IU Bloomington to see if there was a “General Studies Degree” available. To the best of my knowledge, having kept all of her report cards, she had completed 114 hours, you only needed 120 hours to graduate.


IU Bloomington Office of the Recorder’s referred me to the College of Arts & Science – Office of Undergraduate Academic Affairs (Associate Director Aaron Harmon – see email to me). Kristen contacted Clay Packard about her submission of the “Resumption of Undergraduate Studies Inquiry Form”. This “8 week Review” began in roughly early October, 2018. The goal was to get her back in school to complete her undergraduate requirements, beginning in 2019. I was matching Kristen’s payment to IU in order for her to be able to enroll in 2019. She owed \$4,000.00, payment was \$200.00 a month and I matched that.

With IU Bloomington delaying the process, Kristen went to Indiana University Northwest (Branch) and talked to the counselor who completed the “Review Process”.

Kristen began completing the requirements for a *Bachelor’s Degree in General Studies* in January, 2019. In September, 2019 , Kristen informed the counselor that she didn’t need to take one course, which she agreed, and Kristen finished meeting her requirements in the Fall of 2019.


